## Privacy Policy

The International Symposium on Climate-Resilient Agri-Environmental Systems (hereinafter ISCRAES), NOT-FOR-PROFIT, is organised and managed by Prudence College Dublin (PCD) on behalf of the ISCRAES Organising Committee, composed of academics/researchers/stakeholders from national agencies/institutes of Ireland (hereinafter organisers). The College is registered in Ireland with registration number 614903 and its current registered office is at 9, Silken Park Avenue, Dublin 22, Ireland, D22 Y9N1.

This privacy policy is linked to the Terms and Conditions, and the organisers comply with data protection legislation and the General Data Protection Regulation (GDPR) as per Irish and EU policies that regulate the processing of data to ensure your data that are necessary to process fairly and lawfully and kept securely. The organisers collect data primarily to provide you with services you have requested to meet your needs and improve the services provided to you. The organisers may update the privacy policy at any time without notice and will be posted on the ISCRAES website ([www.iscraes.org](http://www.iscraes.org)).

### Collection of Information and Primary Purpose

The personal information you provide is being collected for legitimate symposium-related scientific purposes. During the registration process, you will be asked to provide certain information such as your contact details and symposium-related interests/choices, which will be stored electronically and held in the strictest confidence. The organisers may use the data to (i) contact you about any query you make, services including registration and payments needed, (ii) make any contractual relationship or negotiations, (iii) provide you with relevant information through our engagement programmes, (iv) inform you about the symposium and relevant items of your interest, (v) contact for future events and build scientific collaborations and relationships, and (vi) send a newsletter through subscription, complete a survey through questionnaire or entry to a competition and similar.

In general, the following personal information that is necessary for the purposes mentioned above will be collected (refer to the registration form):

- Full name
- Contact address includes email and telephone number
- Interest areas and preferences
- Use of cookies and log files

The organisers may collect certain information about your computer hardware and software that include but not limited to IP Address, Browser Type, Operating System, Access Times, and Referring Website Addresses. These are used for the operation of the service, maintaining quality of the service, and providing general statistics regarding the use of ISCRAES website.

For legitimate interest, the organisers have balanced their interests with yours considering not to hurt your privacy rights and freedoms. If this arises, you have the option to opt out of the processing of your data.

### Duration of data to be stored

Data is not kept any longer than is required for processing or to comply with the law. As organisers collect data for many different purposes and scientific reasons in the long-term, a single retention period for all data is not feasible for mutually beneficial purposes. The organisers carefully assess the length of time to retain data by legal obligations and thereby remove it from the systems.

### Sharing of Personal Information

The organisers do not sell, trade, or otherwise transfer your personal to outside parties excluding trusted third parties, following GDPR standards, who assist us in organizing the symposium, processing data, operating relevant activities, and providing services to you.

## Cookies

The organisers will use essential and other relevant cookies, containing no confidential information, address, or telephone number on our website(s), which are of global standard, to provide you with a personalised experience and to assist in the collection of the site visitation statistics. The organisers don't exchange cookies with any third-party websites or external data suppliers. You may refuse the cookie but check your browser settings to do so using the "options" or "preferences" menu in your toolbar. Note that not all cookies should be rejected to enable matching of site content appropriate to the preferences given to the organisers by previous visits. Importantly, you will not be able to fully utilise all the website features if rejected in full. ## Security and Confidentiality

The organisers take precautions to protect your personal information using encryption, such as the Secure Socket Layer (SSL) protocol, and limit access to the organiser's office to perform a specific job. The organisers store personally identifiable information on the servers that are kept in a secure environment.

The organisers record details of the financial transaction only, not directly store your debit or credit card information. Online payments are made through our website(s) but are processed securely by a third-party payment provider (here PayPal), the most authentic online payment platform in the world. Appropriate commercially reasonable measures are taken to protect personal information from theft, misuse, or accidental destruction and to keep it confidential. The organisers aim to protect personal information, but cannot provide a 100% guarantee of security.

## Updating or removing information

The organisers make every attempt to keep your personal data accurate, complete, and up to date as submitted. If your personal information is incorrect, or changes, or if you no longer wish to receive information from ISCRAES organisers, please contact [info@israes.org](mailto:info@israes.org) to correct, update or remove your information. This includes opting out of receiving newsletters or promotional materials, and a provision is in place to unsubscribe using the link placed in the footer of the promotional email or by email (where possible). Requests will be dealt with and responded to within a reasonable period, and no longer than 30 days.

The organisers are not obliged to rectify or remove your data. Doing so would prevent you from meeting your contractual obligations to process (including retaining) your personal data for a lawful purpose under the Data Protection Acts. In the event of any conflict between these terms and the provisions of the Data Protection Acts, the Data Protection Acts shall prevail.

## Right of Access
